

2009 INDIVIDUAL OFFICER PISTOL PURCHASE

Beretta USA Corp. recognizes the importance of supporting and assisting the individual law enforcement or security officer and qualified first responders. This program allows these personnel to purchase a Beretta Px4 Storm or 92/90-Two series pistol at special pricing from participating dealers and to receive a \$50 rebate (per pistol) directly from Beretta USA.

For a Beretta Individual Officer Purchase, the following instructions must be followed:

- 1) Complete an Agency Purchase Authorization (APA) letter following the directions below.
- 2) Supply the original APA document to your participating Beretta dealer to receive your special pricing.
- 3) Complete the attached Rebate Form and return this document, together with a copy of the APA and your pistol receipt, to Beretta USA Corp., Attn: Individual Officer Program, 17601 Beretta Drive, Accokeek, MD 20607. Please allow 4-5 weeks for your rebate check to arrive.

The individual officer price includes FET (Federal Excise Tax). Although federal law exempts law enforcement agencies from paying FET, it does not exempt individual officers.

Any trade-in pistol negotiation is between the officer and the dealer.

Beretta retains the right to cancel or modify this program at any time and without notice.

AGENCY PURCHASE AUTHORIZATION (APA) LETTER

The following wording and format must be copied exactly on your **AGENCY OR DEPARTMENT LETTERHEAD**. The original APA submitted to your Beretta dealer must have original signatures in blue ink. Copies, faxed copies, rubber signature stamps or signature copies are NOT permitted.

I understand that the repetitive purchase of firearms for the purpose of resale for livelihood and profit without a Federal Firearms License is a violation of law.
